Course Objectives	<p>The Belt and Road Initiative (BRI) proposed by Chinese government in 2013 has become an important pillar of China's domestic development strategy and its foreign policy. Through the BRI, China is reshaping its relationships throughout Asia and beyond as it engages politically, economically, diplomatically, and culturally with other developing countries and sub-regions. The BRI and its multi-faceted impact has invoked heated discussions, politicized debates and conflicted interpretations of China's motives. In this course, its prime goal is to provide a comprehensive and balanced picture of the BRI and China's growing influence in the developing world. It aims to facilitate students' understanding of the background, policy objectives, and implementation of the BRI. Through the course, we will engage with ongoing debates about China's rise and its international engagement in the developing world.</p>		
Course Description	<p>The course would introduce major motives of the BRI and its key components, and identify distinctive features regarding China's economic, political and cultural engagement in the developing countries. The BRI aims to promote connectivity in the fields of trade, infrastructure, currency through multi-layered collaboration among relevant countries and international organizations. The projects under the BRI are expected to connect the vibrant East Asia economic circle and other economic circles in the world. The BRI may help in consolidating China's status as the largest developing country and promoting South-South cooperation. The course would explain how the BRI is consequential in terms of affecting the development and regional cooperation models in Central Asia, the Middle East, South Asia and other related areas. In addition, students will be asked to make their own inquiries into examples and cases of China's enlarging footprints in the developing countries. Through the combination of lectures, readings, and case studies, the course may assist students to obtain a more informed and balanced understanding of China's changing role on the world stage and its significant impact to other countries in the 21st century. More importantly, the course would encourage students to critically think about the strengths and predicaments of an ascending China.</p>		
Course Requirements:			
<p>Students are required to keep up the readings and engage in active class discussions. Students who can read Chinese will have access to additional reading materials published in Chinese. Attendance is mandatory. Assignments include in-class discussion and presentation as well as a final research paper of about 5-6 pages. Students are expected to make good use of academic research, and multi-media</p>			

platforms to deepen their understanding of selected topics related to China's BRI and its impact in the developing world.

Teaching Methods:

(e.g. Online live lectures, group discussion, etc.)

Due to the Covid-19 pandemic, the course will adopt the format of online live lectures. The course would also include intensive in-class discussions and interactions. Students would be encouraged to conduct some case studies and make presentations based on the peer-group discussions.

Instructor's Academic Background:

Dr. Minghao Zhao is a Senior Fellow at the Center for American Studies, Fudan University. He is also Member of China National Committee, Council for Security Cooperation in the Asia Pacific (CSCAP); Non-resident Senior Fellow at the Institute of International and Strategic Studies, Peking University; Adjunct Senior Fellow at the Center for International Security and Strategy, Tsinghua University. Prior to joining Fudan in 2019, he served as a senior fellow and deputy director for strategic studies at China Center for Contemporary World Studies, the in-house think tank of International Department of the CPC's Central Committee (IDCPC). His research focuses on China's foreign policy, Sino-US relations, and Asia-Pacific security. He is author of *Strategic Restraint: Is New-type Sino-US Relationship Possible* and *The Belt & Road Initiative and China's connectivity-oriented global diplomacy*. He has authored over 40 peer-reviewed scholarly articles and chapters in books. He has been awarded research grants from the National Social Sciences Fund of China, National Development and Reform Commission of China, China Development Research Foundation, the Sumitomo Foundation of Japan, and other institutions. His opinion pieces have been featured in *People's Daily*, *China Daily*, *New York Times*, *Project Syndicate*, *Nikkei Asian Review*, *The Diplomat* among other media outlets. He has contributed policy papers for Center for American Progress, US National Bureau of Asian Research, and Italian Institute of International Affairs among other research institutions. He has held visiting scholarships at research institutions in the United States, Italy, Japan, and Taiwan. He received a Ph.D. in International Relations, a MA in Diplomatic History, and a BA in Art Studies from Peking University. He also earned a LL.M in International Human Rights Law from a joint program by Lund University, Sweden and Peking University.
